A LIVING CRITIQUE OF DOMINATION

BY PROF. MARTIN BREAUGH

Martin Breaugh is an Associate Professor of Political Science at York University (Toronto). He is the author of The Plebeian Discontinuous of Experience: Α History Political Freedom published in Paris in 2007, translated in 2013 at Columbia University Press and to Farsi in 2017 at Qognoos Publications (Teheran). He is also the author of several co-edited volumes, including Thinking Radical Democracy: The Return to Politics in Post-war France, published by Univ. of Toronto Press (2015), and the co-translator of Miguel Abensour's Democracy Against the State: Marx and the Machiavellian Moment, published by Polity Press (2011). He is currently working on a book-length project, tentatively titled The Rule of the Few: On the Political Theory of Oligarchy.
